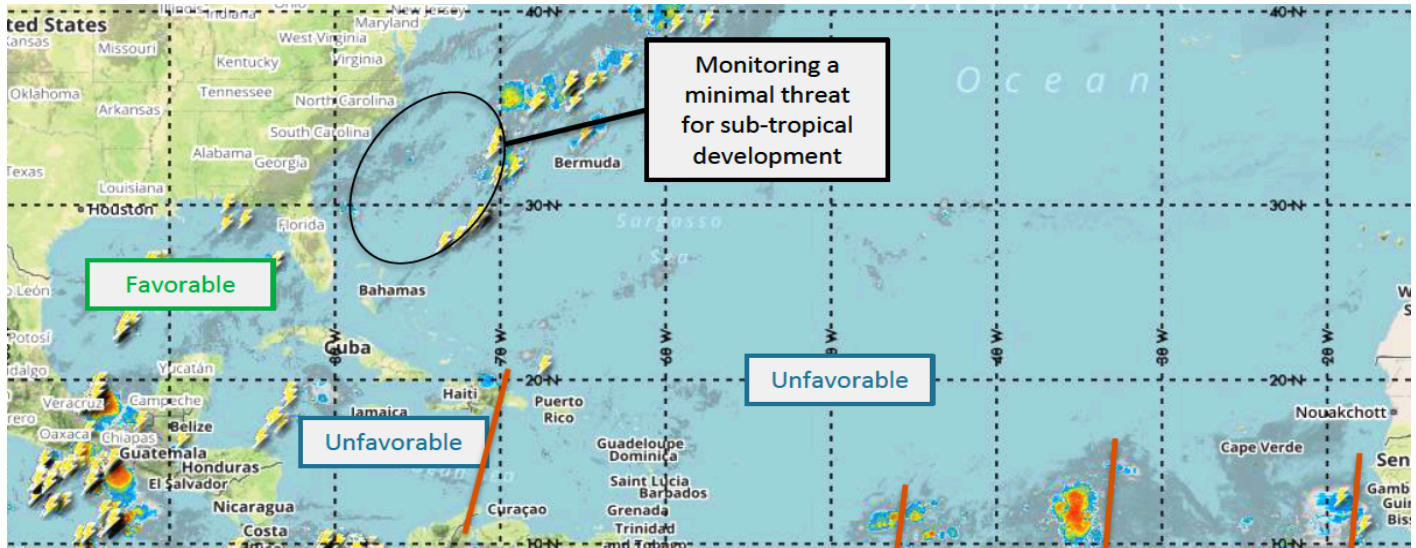

No significant features are present across the Atlantic basin. An area of note is the Western Atlantic which is being monitored for possible tropical or sub-tropical development later this weekend or early next week. An area of low pressure currently over the region will depart to the northeast Friday and Saturday and will leave a weak stationary front over the area. A weak upper disturbance moving westward could interact with the front and increase convective activity and promote low pressure development by early next week. There are only weak signals in the forecast guidance of this occurring, therefore, there is only a minimal chance at this time.

There are a few prominent tropical waves over the central Atlantic that are producing widespread showers/thunderstorms. Although these waves are well defined, environmental conditions across the region are, at best, marginally favorable for tropical development. Forecast guidance shows no signals of further development of these waves as they battle wind shear and pockets of dry air.

There is only a minimal chance for tropical cyclone development over the next seven days.
