## <u>VTS Safety Measure – USACE Vicksburg District Revetment</u> <u>Operations and Restriction/Closure at MM 249 Lower</u> <u>Mississippi River – Update 04</u>

\*\*Update 04\*\* Restrictions are in place from <u>November 26, 2024, to December 3, 2024, from 6:00 A.M. to 6:00 P.M.</u> <u>daily</u> except for the following period with no restrictions: <u>November 29, 2024, at 1:00 P.M. to December 2, 2024, at</u> <u>6:00 A.M.</u>

Southbound Traffic: Tows are limited to 800 feet in length or less and tows 600 feet in length and over must flank, not including the length of the towing vessel.

Northbound Traffic: Tows are limited to 30 barges or less with a maximum length of 6 barges.

- The Captain of the Port New Orleans is issuing a VTS safety measure for the waters of the Lower Mississippi River at mile marker 249. Revetment operations will be conducted from <u>November 26, 2024, to November 28, 2024, from</u> <u>6:00 A.M. to 6:00 P.M. daily, November 29, 2024, from 6:00 A.M. to 1:00 P.M., and from December 2, 2024, to</u> <u>December 3, 2024, from 6:00 A.M. to 6:00 P.M. daily</u> on the right descending bank at Profit Island/Solitude Light.
- 2. <u>No restrictions</u> are in place from <u>November 29, 2024, at 1:00 P.M. to December 2, 2024, at 6:00 A.M.</u>
- 3. At all times, until December 3, 2024, at 6:00 P.M., vessels are required to pass both the Mat Sinking Unit and the Quarters Barge at their slowest safe speed after making passing arrangements with the M/V William James on Marine VHF 13, 16, 82 or by phone at (601) 529-5824.

4. During the revetment operations, the following vessel traffic restrictions are in effect:

## Southbound Traffic:

- Tows are limited to 800 feet in length or less, not including the length of the towing vessel.
- Tows 600 feet in length and over must flank, not including the length of the towing vessel.

## **Northbound Traffic:**

• Tows are limited to 30 barges or less with a maximum length of 6 barges.
