## Dear Facility Security Officer:

This letter provides updated information regarding the seafarers' welfare and labor organizations that serve mariners in our area. As you know, these chaplains and welfare organizations are counselors, liaisons, and human rights ambassadors. Their mission is critical to protecting the basic human rights of seafarers, which does a great deal to promote safety aboard ships and contributes to a safe port environment.

In order to assist in identifying these advocates, an updated list of Seafarer Welfare Organization Representatives is enclosed. This list may be used to validate information provided by persons wishing to gain access to your facility in support of seafarer welfare organizations.

As a reminder, Federal regulations in 33 CFR 105.200(b) (9) require regulated facilities to coordinate access through the facility for representatives of seafarers' welfare and labor organizations. Impeding the ability of these individuals to access the vessels at your facility conflicts with the regulation cited above. All the individuals listed on the enclosure have also purchased and obtained a TWIC card. I greatly appreciate your continued support in ensuring representatives of seafarer's welfare and labor organizations are afforded access to vessels at your facility.

My Facility Compliance Branch will continue to ensure that seafarers are afforded access to these welfare organizations. Thank you for your assistance in this matter and if you have any further questions please contact the Facility Compliance Branch Chief at (504) 365-2375.
